- 3. <u>VALIDITY OF BID</u>. The bid submitted under this tender <u>must be valid for a period</u> of 120 days from the date of closing of tender.
- 4. <u>VALUE ADDED TAX</u>. The Bidders who bid for locally delivered items must have the VAT registration. The VAT portion must be shown separately in the price schedule in Annex "A" and VAT registration number must be indicated.
